


Edit drafted/ planned leave

Users are now able to edit drafted leave requests directly from their mobile devices. This functionality provides greater convenience and flexibility, allowing users to make changes to their leave requests anytime, anywhere. 
Edit incomplete claim / cash advance

Users are now able to edit any incomplete claims or cash advance set by the claim approver. This functionality allows individuals to make the necessary adjustments to their claims before resubmission to ensure the accuracy of the claim details.




IRAS Form

The IRAS form now includes additional form types such as IR8A, Appendix 8A, IR8S, and Appendix 8B, allowing users to conveniently view these forms within the app. This enhancement provides users with easy access to important tax-related documents directly from their mobile devices. This enhancement will exclusively apply to Singapore-based companies and individuals.



Overtime withdrawal

Users can now withdraw pending approval overtime requests directly from their mobile devices. This feature offers greater flexibility and control over managing overtime hours, allowing employees to take back their requests if needed. Whether they've made a mistake in the submissions or their plans have changed, they can quickly withdraw the pending approval without hassle.



Landing Page Promotion
